Therefore, the European Handball Federation, upon the initiative of the Women's Handball board, will invite 10 professional female club managers from the Women's EHF European Cup and Champions League clubs as well as EHF Member Federations employees to participate in the "2014 EHF Club Management Seminar", which will take place in Cologne, Germany from 29 to 31 May 2014, prior to the event of the VELUX EHF FINAL4. Grasp the opportunity and obtain your highly regarded "EHF Club Manager Licence"!

The WHB is delighted to announce that 75% of the seminar Participation Fee will be subsidized by EHF (the optional VELUX EHF FINAL4 package is not included). SELECTION CRITERIA:

- Max. 1 candidate endorsed by her club / federation
- Open to professional female club managers and federations employees
- Provide a current CV focusing of achievements in handball
- Strong knowledge of the English language and application to be completed in English.
- Availability to undertake promotional activities and related interviews as well as provision of personal stories.

In addition to above information the WHB would advise that the participating female club managers at the "2013 EHF Club Management Seminar" can obtain their "EHF Club Manager Licence" by successfully completing and passing the e-learning module (Option 1: 1 April to 15 May 2014 or Option 2: 1 June to 31 July 2014).
